The College Board

The Hamilton and Alexandra College Board consists of individuals with a diversity of skills, qualifications and experience. The Board manages the business and affairs of the College via the Finance and Risk Committee, the Governance Committee and the Strategic Planning Committee.

The Board provides strategic guidance for the school and oversees and reviews management. The Board plays a vital role in the life and security of the College by supporting and advising the Principal in relation to:

- Financial viability the management of the business affairs of the College.
- A culture of safeguarding the school, in both its financial and reputational position.
- Maintaining the school's risk, policy, governance and compliance framework.
- Oversight and planning for capital works and master planning programs.

Additional responsibilities of the College Board include:

- Providing advice and support to the Principal on any matter referred to it by the Principal, or any significant matter that falls within its delegated responsibilities.
- It is an expectation that members must at all times ensure that their decisions are consistent with the ethos of the College as a school in association with the Uniting Church.
